<b>Program</b> Hours of operation	<b>Residential Program</b> Program provides services up to 24 hours per day, 7 days per week in a homelike environment. Lengths of stay vary from respite care, short term rehab, and long term support.			<b>Outpatient Program</b> Monday-Friday 7:00am – 6:00pm (varies based on individual needs)
<b>Geographic Areas Served</b>	Residential homes are in Mason, Michigan Individuals from any geographic area may be served who meet program criteria			In-person services are offered to communities surrounding clinic locations in Lansing and Mason. Telehealth services are delivered using Microsoft Teams for clients in the State of Michigan.

<b>Diagnosis and Medical Status</b>	Stable, free from acute infection or fever, non-ventilator dependent, and requires no advanced medical care. Diagnoses may include neurological, developmental, mental health, and orthopedic conditions. Level of care, funding availability, and other considerations determine appropriateness for and type of program and services. Specific etiology, injury level, completeness, and co-morbidities as it pertains to spinal cord injuries are delineated based on the individual's ability to meet admission criteria.
